Our Programs

CLC provides federal Head Start and Early Head Start along with Connecticut School Readiness and Child Development programs to Stamford and its surrounding communities.

Our comprehensive programs serve children six weeks to five years old. Families pay sliding scale-based fees.

Our play-based learning philosophy allows children to discover the world at their own pace through hands-on, fun activities. Our infant, toddler, and preschool classrooms all use the Creative Curriculum. Backed by comprehensive child development research, our activities are stimulating, hands-on and fun!

Early Head Start serves infants and toddlers providing early, continuous, and comprehensive child development and family support services.

We offer a private pay program for infants and toddlers at our Palmer's Hill location. **43%**

Our programs are accredited by the National Association for the Education of Young Children or monitored through the Office of Head Start review process.

What is it?

Recognize, Understand, Label, Express and

Regulate – it's a way for children to use their emotions effectively – which improves everything from decision making and judgment to physical and mental health, according to Yale researchers. The program is used across all eight CLC locations.

Teachers say:

"It makes them aware of their own feelings and gives them a way to get it out," said Room 5's Head Teacher, Jackie. They learn how to express and understand their feelings, which allows them to understand one another and act with more kindness," she added.

Recognition

The Yale Center for Emotional Intelligence named us this year's Marvin Maurer Award winner for our work developing the Pre-K RULER program. It's given to organizations that exhibit outstanding commitment to promoting emotional intelligence.



Social & Emotional

Social and emotional development is a crucial part of preschool. It's the age children begin to understand the causes of their emotions. Empathy also emerges and for many, it's the first time they are asked to regulate emotions around people outside their families.

Yale researchers, along with CLC teachers, administrators, children and families have created the first early childhood version of the breakthrough RULER program, an innovative approach to social and emotional development.

It's all about helping children manage their emotions to create a better place for learning.

"The early childhood years are a sensitive period for the development of emotional intelligence. Children's language and vocabulary skills are rapidly developing during this time and ensuring that children have the language and strategies they need to manage their emotions can have a profound impact on early childhood classrooms," said Shauna Tominey, Ph.D. and Associate Research Scientist at the Yale Center for Emotional Intelligence.

CLC teachers say RULER helps create calmer atmospheres. They observe students helping each other and find ways to have more pleasant feelings, which improves the learning environment for everyone.

Health & Family

Our holistic approach to early childhood education maximizes the positive impact we have on children's lives. Health maintenance and referrals, nutritious meals, food education, family social services and parent participation activities are integrated daily.

We serve every child breakfast, lunch and a snack that together provide 80% of their daily nutritional needs. Our diverse menu reflects the wide-ranging backgrounds of the families we serve.

During National Nutrition Month in March, we partnered with the Stamford Obesity Prevention Task Force. We promoted healthy activities all month long, including passing out free breakfaststo-go to parents and hosting family fitness activities in the evenings. We also help children and families lead healthy lifestyles through regular exercise programs, including indoor and outdoor play and special programs like dancing.

It's all about encouraging families to make informed food choices and have fun being active together!

Our staff nurses assist teachers in monitoring children's health and create individual health plans for children if they are needed. Family Service Staff help parents with enrollment and offer input on other community agencies that can offer additional support services.

Collaborations

We're making a difference more than ever before thanks to innovative partnerships with some of the best nonprofit organizations in our communities.

As part of Stamford's Vita Health and Wellness District along with Family Centers and Neighbors Link, we've developed the Parents as Co-Educators two-generation program to improve the lives of children from non-English speaking and low-income families.

We believe engaging parents



from homeless to home

as "co-educators," will reduce disparities in public school readiness and ultimately increase socio-economic advancement.

With Inspirica, we're working to end generational homelessness through the Early Childhood and Parenting Program. This pioneering approach provides families daily lessons to foster literacy, social and emotional development along with life skills like cooking. The program received a \$100,000 grant from Impact Fairfield County. Volunteers from Edgehill senior living community -CLC Palmer's Hill neighbors! – continue their regular visits for reading, games, gardening and other fun engagements. The partnership and friendship unites our community across generations.

Stamford Public Schools' Instructional Coordinators help us prepare children for success in public schools and get them excited to make the transition! We're also playing a vital role in the Stamford Cradle to Career initiative.

Volunteers

On a regular basis, volunteers brighten our children's days, help us improve our facilities and provide learning tools for our classrooms. This year's highlights included: from Harvey School visited for special activities and students from King Low Heywood Thomas School partnered with CLC Franklin Commons for reading and play.

Our friends from Pitney Bowes established a lovely routine of monthly reading and play that benefits both children and volunteers.

We dedicated a special library to the memory of Jacek Rakowicz and in honor of his company Legg Mason. He made a lasting impact as a volunteer reader that lives on through this peaceful setting.

Older students from our communities have brought exciting activities to our centers throughout the year. Instructional Coordinators at CLC William Pitt started a Big Brother/Big Sister pen pal program with 4th graders from Springdale School. Volunteers When a young child enters kindergarten ready for school, there is an 82% chance that child will master basic skills by age 11, compared with a 45% percent chance for children who are not school ready.






Revenues
